*1 IN THE MATTER OF GLOBETEL, INC. File No. I-T-C-94-487

Application for authority to acquire and operate facilities for provision of INTELSAT Business Services, INTELNET Service and International Television Service, and to resell switched voice services.

By the Chief, Telecommunications Division:

- 1. Upon consideration of the above-captioned uncontested application, filed pursuant to Section 214 of the Communications Act of 1934, as amended, IT IS HEREBY CERTIFIED that the present and future public convenience and necessity require a grant thereof.
- 2. Accordingly, IT IS ORDERED that application File No. I-T-C-94-487 IS GRANTED, and Globetel, Inc. (Globetel) is authorized to:
- a. establish channels of communication between appropriately licensed U.S. earth stations and appropriate INTELSAT Atlantic and Pacific Ocean Region satellites, for the provision of INTELSAT Business Services (IBS), International Television Service and INTELNET Service between the United States and the points listed in Comsat's Tariff for the space segment of these services;
- b. acquire and operate capacity in the appropriately licensed U.S. earth stations, to be used in conjunction with the space segment capacity;
- c. use the facilities in a. and b. above to provide IBS, International Television Service and INTELNET service; and
- d. provide international switched services by the resale of the international switched voice services set forth in AT & T's Tariff FCC No. 1, MCI's Tariff FCC No. 1, Sprint's Tariffs FCC Nos. 1 and 2, and Worldcom's Tariff FCC No. 1, between the United States and the points listed in those tariffs.
- 3. IT IS FURTHER ORDERED that neither Globetel nor any persons or companies directly or indirectly controlling or controlled by Globetel, or under direct or indirect common control with it, shall acquire or enjoy any right, for the purposes of handling or interchanging traffic to or from the United States, its territories or possessions, which is denied to any other United States carrier by reason of any concession, contract, understanding, or working arrangement to which Globetel or any persons or companies controlling or controlled by Globetel are parties.
- 4. IT IS FURTHER ORDERED that the applicant shall file copies of any operating agreements it enters into with its foreign correspondent with the Commission within 30 days of its execution, and shall otherwise comply with the filing requirements contained in Section 43.51 of the Commission's Rules, 47 C.F.R. § 43.51.
- *2 5. IT IS FURTHER ORDERED that the applicant shall file a tariff pursuant to Section 203 of the Communications Act, 47 U.S.C. § 203, and Part 61 of the Commission's Rules, 47 C.F.R. Part 61, for the services authorized in this Order.
- 6. IT IS FURTHER ORDERED that the applicant shall file the annual reports of overseas telecommunications traffic required by Section 43.61 of the Commission's Rules, 47 C.F.R. § 43.61.

- 7. The Commission retains jurisdiction over this matter to reallocate circuits in the satellite system among the various international common carriers and other authorized users as required to ensure nondiscriminatory use of, and equitable access to, the communications satellite system.
- 8. This order is issued under Section 0.261 of the Commission's Rules and is effective upon adoption. Petitions for reconsideration under Section 1.106 or applications for review under Section 1.115 of the Commission's Rules may be filed within 30 days of the date of public notice of this order (see Section 1.4(b)(2)).
