- ITC-214-19950805-00017 for the provision of resale private lines not interconnected to the public switched network;
- ITC-214-19950805-00018 for the provision of resale international switched services;
- ITC-214-19950805-00019 for the provision of resale private lines interconnected with the public switched network at one or both ends for switched services;
- ITC-214-19960118-00005 for the provision of resale interconnected private lines between the U.S. and Sweden;
- ITC-214-19960723-00335 for the provision of facilities-based service to operate facilities to Canada and beyond;
- ITC-214-19960723-00336 for the provision of limited global resale service to lease private lines between the U.S. and Canada for switched and private line services; and
- ITC-214-19960806-00371 for the provision of limited global facilities-based authority for all international points except Canada.
