**Re: Surrender of Certain International Section 214 Authorizations
of the Cleartel Entities**

Corrected Section 63.21(h) Notice of the Cleartel Entities

Dear Ms. Dortch:

On behalf of Cleartel Communications, Inc. (“CCI”), Cleartel Telecommunications, Inc. (“CTI”), IDS Telcom Corp. (“IDS”), nii communications, ltd. (“nii”), Now Communications, Inc. (“NOW”), Supra Telecommunications and Information Systems, Inc. (“Supra”), and Telecon Communications Corporation (“TCC”) (collectively, the “Cleartel Entities”), this letter, as more fully described below, (1) surrenders certain International Section 214 Authorizations of the Cleartel Entities and (2) notifies the Commission that CTI, IDS, nii, NOW, Supra and TCC will provide service under the international Section 214 authorization held by their ultimate parent company CCI. These actions are being undertaken to reduce the administrative burden on the Cleartel Entities associated with maintaining multiple International Section 214 authorizations.

Surrender of Certain International Section 214 Authorizations

In order to reduce the administrative burden associated with maintaining multiple International Section 214 authorizations, the Cleartel Entities have decided to surrender, effective as of the date of this letter, the following International Section 214 authorizations (the “Surrendered Authorizations”):

Corrected Section 63.21(h) Notice of the Cleartel Entities

Pursuant to Section 63.21(h), 47 C.F.R. § 63.21(h), and effective as of the date of the original Section 63.21(h) Notice filed on May 8, 2009, CTI, IDS, nii, NOW, Supra, and

¹ The Commission's International Bureau Filing System ("IBFS") indicates that the international Section 214 authorizations granted in IB File Nos. ITC-214-19970207-00068 and ITC-214-20020903-00451 are held by CCI. Those two authorizations were originally granted to a company named Supra Telecommunications and Information Systems, Inc. ("Old Supra"), which assigned certain of its assets to CTI and Supra (then known as Supra Telecommunications and Information Systems Acquisition Corp.). See IB File No. ITC-ASG-20060731-00376. However, as indicated in the Public Notice granting the assignment of assets, Old Supra was to retain the international Section 214 authorizations and Supra would provide international telecommunications services pursuant to the international Section 214 authorizations of CCI and CTI. To the extent that these international Section 214 authorizations of Old Supra were in fact assigned to CCI, CCI surrenders them. Otherwise, the Commission's records should be updated to reflect that the international Section 214 authorizations granted in IB File Nos. ITC-214-19970207-00068 and ITC-214-20020903-00451 are actually in the name of Old Supra. Since Old Supra dissolved following the transaction and before Supra changed its name to match Old Supra's name, the Commission may wish to cancel those international Section 214 authorizations to avoid any future confusion.
