
Dear Ms. Dortch:

Pursuant to 47 C.F.R. §63.24(e)(4), this notice is to inform the Commission that, on February 8, 2018, consummation occurred of the transfer of control of Gridley Telephone Company ("GTC") and Gridley Communications, Inc. ("GCI") to Egyptian Communication Services, Inc.
