Dear Ms. Dortch:

One Communications Corp. ("One Communications"), by its attorney, hereby (1) notifies the Commission that certain of its subsidiaries will operate pursuant to its international Section 214 authority, pursuant to Section 63.21(h) of the Commission's Rules; and (2) on behalf of certain subsidiaries, surrenders these subsidiaries' international Section 214 authorizations. One Communications is the surviving entity resulting from the merger of CTC Communications Group, Inc. ("CTC Group") and Choice One Communications, Inc. ("Choice One"). The merger of CTC Group and Choice One was authorized by the Commission on June 26, 2006 in WC Docket No. 06-47 and IB File Nos. ITC-T/C-20060222-00100, ITC-T/C-20060222-00101, ITC-T/C-20060222-00102, ITC-T/C-20060222-00103, ITC-T/C-20060222-00105, and ITC-T/C-20060222-00106. The merger was consummated on June 30, 2006. Subsequent to the merger but on that same date, One Communications acquired control of Conversent Communications, Inc. ("Conversent"). The Commission authorized One Communications' acquisition of Conversent in WC Docket No. 06-85 and File Nos. ITC-T/C-20060410-00227, ITC-T/C-20060410-00228, and ITC-T/C-20060410-00229.

Section 63.21(h) Notice of Subsidiary Operation

Effective July 7, 2006, certain subsidiaries of One Communications commenced operating under One Communication's international Section 214 authority. The names of the subsidiaries and their places of legal organization are provided in Attachment 1. One Communications' international Section 214 authority was granted in IB File No. ITC-214-20040708-00260. CTC Communications Corp., a wholly-owned indirect subsidiary of One Communications, assigned this international Section 214 authorization to One Communications on July 7, 2006, as explained in the Section 63.24(f) notice of *pro forma* assignment that One Communications is filing via IBFS currently with the submission of this letter. A copy of One Communications' *pro forma* assignment notice is provided in Attachment 2.


Surrender of Section 214 Authority

One Communications Corp. (“One Communications”), by its attorney, hereby notifies the Commission of a *pro forma* assignment of an international Section 214 authorization pursuant to Section 63.24(f) of the Commission’s Rules. One Communications is the surviving entity resulting from the merger of CTC Communications Group, Inc. (“CTC Group”) and Choice One Communications, Inc. (“Choice One”). The merger of CTC Group and Choice One was authorized by the Commission on June 26, 2006 in WC Docket No. 06-47 and IB File Nos. ITC-T/C-20060222-00100, ITC-T/C-20060222-00101, ITC-T/C-20060222-00102, ITC-T/C-20060222-00103, ITC-T/C-20060222-00105, and ITC-T/C-20060222-00106. The merger was consummated on June 30, 2006. Subsequent to the merger but on that same date, One Communications acquired control of Conversent Communications, Inc. (“Conversent”). The Commission authorized One Communications’ acquisition of Conversent in WC Docket No. 06-85 and File Nos. ITC-T/C-20060410-00227, ITC-T/C-20060410-00228, and ITC-T/C-20060410-00229.

CTC Communications Corp. (“CTC Corp”), a Massachusetts corporation, has assigned its international Section 214 authority granted in IB File No. ITC-214-20040708-00260 to One Communications. The date of the assignment was July 7, 2006. CTC Corp is a wholly-owned indirect subsidiary of One Communications and thus this assignment is *pro forma*. In

*CVC Broadband*. Columbia Ventures Broadband LLC (“CVC Broadband”), a Washington state limited liability company that is a holding company, holds a 50 percent ownership interest in One Communications and was authorized by the Commission in Docket No. WC 06-85 to hold up to a 70 percent ownership interest. CVC Broadband is, in turn, a wholly-owned subsidiary of Columbia Ventures Corporation (“CVC”), a Washington state corporation. CVC owns and operates a portfolio of telecommunications companies and a small number of manufacturing businesses around the world. Mr. Kenneth D. Peterson, Jr., a U.S. citizen, holds 100 percent of the ownership interest in CVC. Mr. Peterson is Chief Executive Officer, Chairman and Founder of CVC. The address of CVC Broadband, CVC, and Mr. Peterson is 203 SE Park Plaza Drive, Suite 270, Vancouver, WA 98684.

*Quantum Partners LDC*. Quantum Partners LDC (“Quantum”) holds a 13 percent ownership interest in One Communications. Quantum is a Cayman Islands limited duration corporation whose principal business is investment. Quantum is wholly owned by Quantum Emerging Growth Partners, C.V. (“Quantum Emerging”), a Netherlands Antilles limited partnership whose principal business is investment. The managing general partner of Quantum Emerging is Emerging Growth Fund Management C.V. (“Emerging Growth”), a Netherlands Antilles limited partnership whose principal business is investment. The managing general partner of Emerging Growth is Quastro N.V. (“Quastro”), a Netherlands Antilles corporation whose principal business is investment. The address of Quantum, Quantum Emerging, Emerging Growth and Quastro is Kaya Flamoyan 9, Willemstad, Curaçao, Netherlands Antilles. The sole shareholder of Quastro is George Soros, a U.S. citizen whose principal business is being Chairman of Soros Fund Management LLC (“SFM”). SFM, which is a Delaware limited liability company, by virtue of a management agreement between SFM and Quantum, exercises voting and dispositive power over the shares of Choice One held by Quantum. The address of SFM and George Soros is 888 Seventh Avenue, New York, NY 10106.

No other person or entity holds a 10 percent or greater ownership interest in One Communications. There are no interlocking directorates.

The certificate required by Section 63.24(f)(2)(ii) is provided in Attachment 1.


