Pursuant to recent discussions with the staff of the International Bureau, the purpose of this letter is to formally advise the Commission that on November 14, 2002, Arrowhead Space and Telecommunications, Inc., which holds the above-captioned authorization to provide facilities-based international service pursuant to Section 214 of the Communications Act of 1934, as amended, changed its name to Arrowhead Global Solutions, Inc. Arrowhead first brought this name change to the Commission's attention in an application for authority for transfer of control of Arrowhead from its current shareholders to CapRock Communications, Inc., filed February 28, 2007 and, at the staff's request, provided further information on this matter in an e-mail to Ms. Sumita Mukhoty of the International Bureau on March 7, 2007.

The management of Arrowhead has advised the undersigned counsel that, at the time of this name change, they were not aware of the Commission's notification requirement regarding name changes, and that they apologize for this oversight. Arrowhead therefore respectfully requests that the Commission accept this letter as formal notification of Arrowhead's name change, and that the Commission waive its rules to allow for this late-filed notification.
