AT&T Broadband Phone of Texas, LLC (the "Company"), by its attorneys, hereby respectfully notifies the Federal Communications Commission (the "Commission") that its name has been changed to Comcast Phone of Texas, LLC, d/b/a Comcast Digital Phone. AT&T Broadband Phone of Texas, LLC currently is authorized by the Commission to provide global resale service pursuant to **File No. ITC-214-19970805-00468**, granted on September 19, 1997. This name change is related to the merger of AT&T Broadband Corp., including its telephony operations, with Comcast Corporation, which was approved by the Commission on November 14, 2002.<sup>1</sup> The Company implemented the name change on March 18, 2003.
