Important Notice Regarding the Planned Discontinuance of ISDN/PRI and Analog Phone Services Provided by TelCove Operations, LLC

This letter serves as formal notice that TelCove Operations, LLC (a Level 3 company) will be discontinuing its ISDN/PRI and Analog Phone services in the Savannah, Georgia metropolitan area, subject to the approval of the Federal Communications Commission (FCC) on or after June 30, 2017. TelCove Operations, LLC is required by the FCC to provide the following statement:

Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
