Notification of Discontinuance of International Telecommunications

Dear Ms. Dortch:

Pursuant to Section 63.19(a) of the Commission's rules, Telefónica Larga Distancia de Puerto Rico, Inc. ("TLD") informs the Commission that TLD plans to discontinue its international telecommunications services to residential and small office/home office ("SOHO") customers in Puerto Rico and the U.S. Virgin Islands as of January 26, 2018.¹ As relevant to these services, TLD holds International Section 214 authorization ITC-214-19980130-00056. TLD is non-dominant in Puerto Rico and the U.S. Virgin Islands with respect to these and other telecommunications services. An original and five copies of this letter are being submitted to the Office of the Secretary, along with a copy to the Chief, International Bureau.

On November 27, 2017, TLD notified each affected customer of the proposed discontinuance by mail to the customer's billing address on file with TLD. Each customer received a copy of the notice in Spanish and English, in the form shown in Exhibit A attached hereto.

¹ TLD also plans to discontinue its provision of domestic telecommunications services to residential and SOHO customers in these territories, and the company contemporaneously is filing an application for authority to discontinue those services in accordance with 47 C.F.R. § 63.71.

Por la presente le informamos que efectivo el 26 de enero de 2018 Telefonica Larga Distancia de Puerto Rico, Inc. ("TLD") cesará de brindar servicio a sus clientes residenciales y de pequeñas oficinas u oficinas en la casa ("SOHO" del inglés small office/home office) en Puerto Rico y las Islas Vírgenes de los Estados Unidos. Estos servicios incluyen: servicio de telefonía local, telefonía de larga distancia intra-isla, interestatal e internacional. Esto incluye los servicios que TLD actualmente le provee a usted.

Usted puede solicitar la cancelación del servicio en cualquier momento, previo a dicha fecha, sin penalidad. Le exhortamos a consultar con otros proveedores de servicio de modo que pueda continuar recibiendo los servicios a través de su nuevo proveedor de servicio seleccionado. De todos modos le advertimos que los servicios de TLD descontinuarán el 26 de enero de 2018.

Como parte del proceso de descontinuación del servicio TLD le notificará tanto a la Junta Reglamentadora de Telecomunicaciones de Puerto Rico ("JRTPR") como a la Comisión Federal de Comunicaciones ("FCC"). Por lo general la FCC autoriza las peticiones de descontinuación de servicio a menos que los clientes demuestren que no podrán de otro modo recibir los servicios, o un sustituto razonable, o que la necesidad pública o conveniencia se verá adversamente afectada. Si usted desea objetar deberá presentar sus comentarios y objeciones dentro de los quince (15) días desde que la FCC emita un aviso público sobre la descontinuación de servicio propuesta. Usted podrá presentar sus comentarios electrónicamente a través del Sistema de radicaciones electrónicas de la FCC (FCC's Electronic Comment Filing System) utilizando el número de caso que aparezca en el aviso público de la FCC para este proceso, o podrá enviar sus comentarios a la siguiente dirección: Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, e incluir en sus comentarios una referencia a la Petición de TLD bajo la sección §63.71. Los comentarios deben incluir información específica del impacto que tendría la descontinuación de servicio propuesta para usted o su compañía, incluyendo su inhabilidad de poder conseguir un proveedor sustituto razonable.

Dear Customer:

This is to inform you that effective January 26, 2018 Telefonica Larga Distancia de Puerto Rico, Inc. ("TLD") will no longer provide service to its residential and SOHO (small office/home office) clients in Puerto Rico and the U.S. Virgin Islands. These services include: local services, intra-island long distance service, interstate and international long distance service. This includes the services TLD currently provides to you.

You may request the cancellation of the service at any time, prior to this date, without charges or penalties. We encourage you to consult with other service providers, so that you may continue receiving the services from your new selected service provider. In any event, TLD's services will be discontinued on January 26, 2018.

As part of the discontinuation process TLD will notify both the Telecommunications Regulatory Board of Puerto Rico ("TRBPR") and the Federal Communications Commission ("FCC"). Please note that the FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute service from another carrier, or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the FCC releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the FCC's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the §63.71 Application of TLD. Comments should include specific information about the impact of this proposed discontinuance (or reduction or impairment) upon you or your company, including any inability to acquire reasonable substitute service.
