Dear Ms. Dortch:

Global Crossing Telecommunications, Inc. ("GC Telecom") (FRN: 0002850519), by its attorney and pursuant to Section 63.24(f) of the Federal Communication Commission's ("Commission's" or "FCC's") Rules, 47 C.F.R. § 63.24(f), hereby notifies the Commission of the merger of Global Crossing North American Networks, Inc. ("GC Networks") (FRN: 0007544547) into GC Telecom and *pro forma* transfer of control of GC Networks' to GC Telecom. GC Telecom and GC Networks are authorized to provide international telecommunications services pursuant to the Section 214 authority, 47 U.S.C. § 214, granted to their mutual parent company, Global Crossing North America, Inc., in File No. ITC-214-19980520-00334.¹ GC Networks was merged into GC Telecom on December 31, 2010, and GC Telecom is the surviving company. Since GC Networks, like GC Telecom, was a wholly-owned indirect subsidiary of Global Crossing North America, Inc., the merger of GC Networks into GC Telecom was a *pro forma* transaction subject to the post-consummation notification requirement under Section 63.24(f) of the Commission's Rules.
