I. Preamble

ClearCom Corporation ("ClearCom"), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Section 63.18, to provide global international facilities-based and resale services between the United States and international points.

ClearCom is a new U.S. company organized to provide international telecommunications services. ClearCom has no foreign affiliations. ClearCom serves business customers throughout the United States.

By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to ClearCom.
