

Local Exchange Carrier Affiliation

ELITel: (1) will maintain separate books of account from Ellensburg Telephone Company and other local exchange carriers owned by MJD Ventures, Inc. and MJD Communications, Inc.; (2) will not jointly own transmission or switching facilities with Ellensburg Telephone Company or other local exchange carriers owned by MJD Ventures, Inc. and MJD Communications, Inc.; and (3) will take any tariffed services from Ellensburg Telephone Company and other local exchange carriers owned by MJD Ventures, Inc. and MJD Communications, Inc. pursuant to the terms and conditions of their generally applicable tariffs.

ELITel will be treated as a nonregulated affiliate of Ellensburg Telephone Company for purposes of local exchange carrier accounting under the Commission's joint cost and affiliate transactions rules as set forth in Parts 32 and 64 of the Commission's Rules.



Foreign Concessions and Arrangements

ELITel hereby certifies that it has not agreed to accept special concessions, directly or indirectly, from any foreign carrier or foreign administration with respect to traffic and revenue flows between the United States and any foreign country which the Applicant may serve under the authority sought; and that it will not enter into such agreements in the future.
