Dear Ms. Dortch:

Fusion, LLC (“Fusion”),¹ by its attorneys, hereby notifies the Federal Communications Commission (“Commission”) that Fusion is surrendering its international Section 214 authorization (File No. ITC-214-19990127-00044) effective immediately.

Fusion is not discontinuing its service operations and, by separate filing, has notified the Commission that Fusion will be operating pursuant to the international Section 214 authorization held by its indirect parent, Fusion Connect, Inc.² Consequently, as service is not being discontinued for any customers, there are no customers to be notified in accordance with Section 63.19(a)(1) of the Commission’s Rules, and no customer notification is attached to this letter.


