Pursuant to Section 63.21(h) of the Commission's rules, 47 C.F.R. § 63.21(h), Innovative Communication Corporation, Stan Springel, Chapter 11 Trustee (hereinafter "ICC"), by undersigned counsel, hereby provides notice to the Federal Communications Commission regarding the provision of international service by ICC through its wholly-owned subsidiary ICC Long Distance, Inc. d/b/a Innovative Long Distance ("ILD").
