Pursuant to Section 63.24(d) and (f) of the Commission's rules, Cable & Wireless Global Network Limited (Ireland) ("CWGN"), by its attorneys, hereby notifies the Commission that a *pro forma* transfer of control of the above-referenced authorizations was consummated on December 16, 2003. 47 C.F.R. § 63.24(d) and Note 2, and (f). CWGN remains the holder of the authorizations and the only change is the insertion of a wholly-owned intermediate company, Sable Holding Ltd. immediately below CWGN's ultimate parent company. Enclosed herewith are (i) the information required by Section 63.24(f); and (ii) a set of charts reflecting the *pro forma* nature of the change from the pre-consummation ownership structure of CWGN (Exhibit 1) to the current, post-consummation ownership structure of CWGN (Exhibit 2).

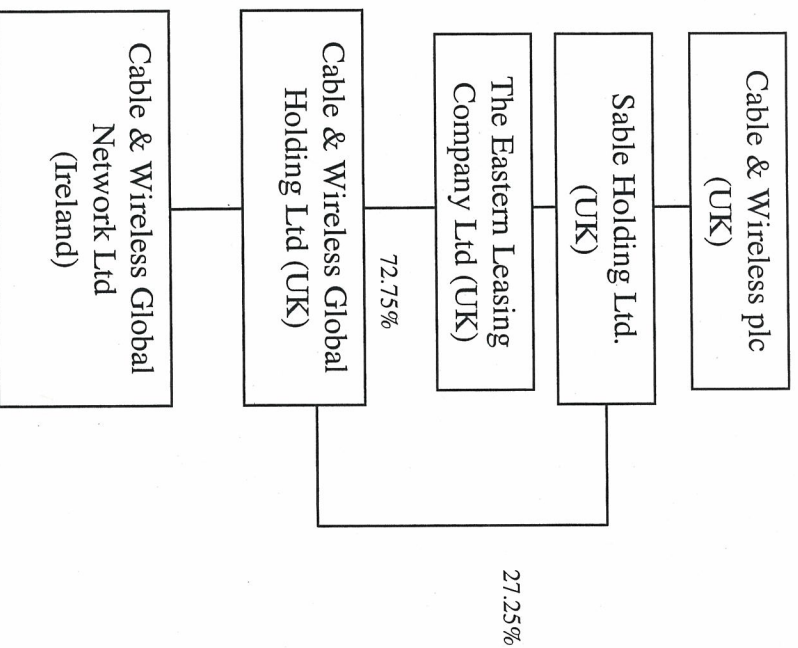
