Dear Ms. Dortch:

By this letter, Level 3 Communications, LLC ("Level 3"), surrenders the international Section 214 authorization, FCC File No. ITC-214-19990708-00391, assigned to Level 3 as part of its acquisition of the assets of Genuity Telecom, Inc., Debtor-in-Possession ("Genuity"). The Commission originally granted the authorization to Genuity's predecessor-in-interest, GTE Telecom Incorporated, and consented to its assignment to Level 3 in order to allow Level 3 to acquire network assets and customers from Genuity. *See International Authorizations Granted, Public Notice*, 18 FCC Rcd. 777 (2003); FCC File No. ITC-ASG-20021216-00592.


This authorization is dormant and duplicative, as Level 3 provides international telecommunications services to the customers it acquired from Genuity by relying on its own, separate international Section 214 authorization for global facilities-based and global resale services. Moreover, the residual authority retained by Genuity for purposes of serving certain customers accounts that it did not transfer to Level 3 was surrendered by Genuity's successor in interest, GLT Liquidating Trust, as of March 5, 2004. *See International Authorizations Granted, Public Notice*, 19 FCC Rcd. 7116, 7119 (2004). Consequently, Level 3 is surrendering the authorization.
