APPLICATION

NOW Communications, Inc. (ANOW≅ or AApplicant≅), by its undersigned counsel, hereby requests global resale authority, under Section 214 of the Communications Act of 1934, as amended (the AAct≅), 47 U.S.C. ∋ 214, and Section 63.18 of the Commission's Rules, 47 C.F.R. ∋ 63.18, to provide international telecommunications services between the United States and international points.

I. The Applicant

NOW is a corporation organized under the laws of the State of Mississippi. NOW is not affiliated, within the meaning of Section 63.09(e) of the Commission=s Rules, 47 C.F.R. → 63.09(e), with a foreign carrier. As described in greater detail below, because NOW is not affiliated with a foreign carrier and is not a foreign carrier in a particular country to which it provides service, NOW qualifies for the presumption of non-dominance under Section 63.10(a)(1) of the Commission=s Rules, 47 C.F.R. → 63.10(a)(1), and therefore, this application is eligible for streamlined processing pursuant to 47 C.F.R. → 63.12.

II. <u>Public Interest Considerations</u>

NOW believes that the added competition its entry will bring to the market will benefit the

consumers of United States-overseas services. These benefits include competitive pricing and

increased availability of a variety of service options. Therefore, a grant of this Application will further

the public interest.
