Surrender of Authority to Provide Service to Macedonia

Dear Ms. Salas:

Deutsche Telekom, Inc. ("DTI"), by its attorneys, hereby surrenders its authority under Section 214 of the Communications Act of 1934, as amended, to provide international telecommunications services between the U.S. and the Former Yugoslav Republic of Macedonia. DTI is surrendering this authority because it has acquired an affiliation with Makedonski Telekomunikacii, the primary provider of telecommunications services in Macedonia. The Former Yugoslav Republic of Macedonia is not a member of the World Trade Organization. DTI does not currently provide, and has never provided, telecommunications service pursuant to its Section 214 authorization between the U.S. and Macedonia.

DTI's authority to provide service to Macedonia was granted as a part of DTI's limited global facilities-based and resale authority. This authority was granted on January 12, 2000 in File No. ITC-214-19991217-00787. By this letter, DTI is surrendering only its authority to provide service to Macedonia. All other authority granted in File No. ITC-214-19991217-00787 will remain in effect. DTI is not submitting a separate notice of discontinuation of service on this route because, as noted above, DTI does not provide service on the U.S.-Macedonia route to any subscriber.
