



ezTel Network Services, LLC ("ezTel" or "Applicant"), by its attorney, hereby respectfully requests authority from the Federal Communications Commission ("Commission"), pursuant to Section 214 of the Communications Act of 1934, as amended (the "Act"), and Section 63.18 of the Commission's Rules, to provide global international facilities-based and resale services between the United States and international points. In accordance with the Commission's fee schedule, Fee Code CUT, ezTel Network Services, LLC has attached a check in the amount of \$780.00 to this Application.

ezTel Network Services, LLC is a U.S. company formed on December 10, 1999 to provide telecommunications services to business and residential customers throughout the United States.

By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit US consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to eZTel Network Services, LLC.
