AMERICAS.com Corp. ("Applicant"), pursuant to Section 214 of the Communications Act of 1934, as amended (47 U.S.C. § 214) and Section 63.18 of the Commission's rules (47 C.F.R. § 63.18), hereby applies for such authority as may be required to operate as a facilities-based carrier to provide international basic switched, private line, data, television, and business services to all international points permitted to be served by the Commission. In addition, the Applicant applies for such authority as may be required to resell the international services of authorized United States common carriers, including international private lines interconnected with the public switched network to the extent permitted by the Commission's rules, for the provision of international basic switched, private line, data, television, and business services to all international points.

Grant of this application will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S.

consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to the Applicant.
