APPLICATION FOR AUTHORITY UNDER  
SECTION 214 OF THE COMMUNICATIONS ACT

Rainbow Telephone Cooperative Association, Inc. (RTCA) hereby requests, pursuant to Section 214 of the Communications Act of 1934, as amended, and Sections 63.18 (e) (2) and 63.12 of the Commission's Rules,<sup>1</sup> authority to resell international message telephone service ("IMTS") between points in the United States and various international points by reselling the services of unaffiliated carriers. Because RTCA is not affiliated with a foreign carrier and is not affiliated with the U.S. facilities-based carriers whose international services it wishes to resell, RTCA's application should properly qualify for streamlined treatment under Section 63.12 of the Commission's Rules, unless formally opposed.<sup>2</sup>

RTCA's entry into the international market will promote competition and stimulate more efficient use of telecommunications resources. Moreover, RTCA is legally, financially, and technically qualified to provide the requested services. In support of RTCA's request for authorization, the following information is set forth in accordance with Section 63.18:

(d) Applicant is not presently subject to Section 214 of the Act, but will become subject to Section 214 as a result of its proposed international service resale operations.

- (e) The applicant is requesting authority to resell the international services of authorized U.S. common carriers for the provision of international basic switched, private line, data, television and business services to all international points. Thus, it is requesting authority to operate as a resale carrier pursuant to the terms and conditions of Section 63.18(e)(2). At this time, the applicant is not seeking authority to operate as a facilities-based carrier.

#### Certifications

- (1) RTCA hereby certifies that it is not owned by or affiliated with a foreign carrier for purposes of Section 63.18(h) of the Commission's Rules.<sup>3</sup>
- (2) In support of this certification RTCA provides the following stockholder information:
  - No shareholder has ten percent or greater ownership in Rainbow Telephone Cooperative Association, Inc.
- (4) RTCA hereby certifies that it is not affiliated with the U.S. carriers whose facilities-based services it proposes to resell.
- (5) RTCA hereby certifies that no party to the application is subject to a denial of the Federal benefits requested herein pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988.<sup>4</sup>
- (6) RTCA hereby certifies that it has not agreed to accept special concessions directly or indirectly from any foreign carrier or administration with respect to traffic or revenue flows between the U.S. and any foreign country which it may serve under the authority granted under this part and will not enter into such agreements in the future.
