## **I. Introduction**

Through this application, East Star, a Delaware limited liability company, seeks authority to provide international services as a facilities-based and resale carrier between the United States and all authorized international points. The public interest in more competitive and economical international communication services is well established and has been addressed by the Commission in numerous decisions. East Star therefore submits that streamlined grant of this application is in the public interest.
