St. John Cooperative Telephone & Telegraph Co. ("SJCTT") is a local exchange carrier. It is a cooperative, and has no entity with a ten percent (10%) or greater ownership interest.

Coin: (1) will maintain separate books of account from SJCTT, its affiliated local exchange carrier; (2) will not jointly own transmission or switching facilities with SJCTT; and (3) will take any tariffed services from SJCTT pursuant to the terms and conditions of SJCTT's generally applicable tariffs.

Coin will be treated as a nonregulated affiliate of SJCTT for purposes of local exchange carrier accounting under the Commission's joint cost and affiliate transactions rules as set forth in Parts 32 and 64 of the Commission's Rules.

#### Foreign Concessions and Arrangements

Coin hereby certifies that it has not agreed to accept special concessions, directly or indirectly, from any foreign carrier or foreign administration with respect to traffic and revenue flows between the United States and any foreign country which the Applicant may serve under the authority sought; and that it will not enter into such agreements in the future.

Anti-Drug Abuse Act Certification

Coin certifies that, to the best of its knowledge and belief, no party to the application is subject to denial of Federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. 862.


