APPLICATION FOR AUTHORITY UNDER  
SECTION 214 OF THE COMMUNICATIONS ACT

Elsie Communications, Inc. (ECI) hereby requests, pursuant to Section 214 of the Communications Act of 1934, as amended, and Sections 63.18 (e) (2) and 63.12 of the Commission's Rules,<sup>1</sup> authority to resell international message telephone service ("IMTS") between points in the United States and various international points by reselling the services of unaffiliated carriers. Because ECI is not affiliated with a foreign carrier and is not affiliated with the U.S. facilities-based carriers whose international services it wishes to resell, ECI's application should properly qualify for streamlined treatment under Section 63.12 of the Commission's Rules, unless formally opposed.<sup>2</sup>

ECI's entry into the international market will promote competition and stimulate more efficient use of telecommunications resources. Moreover, ECI is legally, financially, and technically qualified to provide the requested services. In support of ECI's request for authorization, the following information is set forth in accordance with Section 63.18:

Thus, it is requesting authority to operate as a resale carrier pursuant to the terms and conditions of Section 63.18(e)(2). At this time, the applicant is not seeking authority to operate as a facilities-based carrier.
