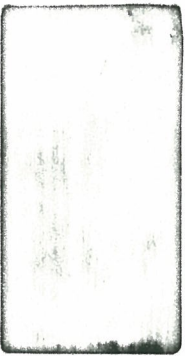

Streamline Processing Requested**

Amcom L.L.C. ("Amcom"), pursuant to Section 63.18(e)(2) of the Commission's Rules, hereby requests authority under Section 214 of the Communications Act of 1934, as amended, to provide global facilities-based and resale of public switched services. By granting this application, the Commission will promote competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Accordingly, the public interest will be served by the Commission's grant of Section 214 authority to Amcom under its streamlined processing rules.

Section 63.18 Information

The following information is submitted, as required by Section 63.18 of the Commission's rules, in support of Amcom's request for Section 214 authority to provide global resale of public switched services:

Amcom requests streamline processing of this application pursuant to Section 63.12 of the Commission's rules. The streamlined processing procedures are appropriate because Amcom: (1) is not affiliated with a foreign carrier in a destination market; (2) is not affiliated with a dominant United States carrier whose international switched or private line services the applicant seeks authority to resell (either directly or indirectly through the resale of another reseller's services); (3) does not seek authority to provide switched basic services over private lines to a country for which the Commission has not previously authorized the provision of switched services over private lines; and (4) has not been informed by the Commission that the application is not eligible for streamlined processing.

Conclusion

For these reasons, Amcom respectfully requests that the Commission grant this application.
