Pursuant to Section 63.21(h) of the Commission's rules, 47 C.F.R. § 63.21(h), ACC Acquisition LLC ("ACC"), by its attorneys, hereby notifies the Commission that its wholly-owned subsidiary, American Cellular Wireless, LLC ("ACW"), began providing service earlier this year pursuant to ACC's international Section 214 authorization, File No. ITC-214-20000428-002255.¹ ACW is organized in the State of Delaware.

¹ The Commission's International Bureau Electronic Filing System incorrectly lists Celco Partnership as the holder of this authorization. ACC believes this is a result of a prior transaction involving, ACC of Tennessee License LLC, a subsidiary of ACC that operated under this authorization, in which spectrum licenses and underlying derivative international Section 214 *authority* were either transferred or assigned to Celco Partnership. See File Nos. ITC-ASG-20011119-00609, ITC-ASG-20011119-00610, and ITC-T/C-20011119-611. However, ACC did not transfer control or assign the authorization and remains the authorized holder. ACC has previously requested that the Commission's staff correct its records in this regard and hereby reiterates this request for correction.
