STREAMLINED SECTION 214 APPLICATION

I. INTRODUCTION

Global One Communications L.L.C. (“Global One”) hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and Section 63.18(e)(1) and (2) of the Rules of the Federal Communications Commission (“FCC” or “Commission”), 47 C.F.R. § 63.18, to acquire facilities and to operate as a global facilities-based and resale carrier and to provide switched services over private lines, except between the U.S. and France, the Central African Republic, Chad, Cote d’Ivoire, Djibouti, El Salvador, Equatorial Guinea, French Guiana, French Polynesia, Guadeloupe, Madagascar, Martinique, Mayotte, New Caledonia, Reunion Island, Saint Pierre and Miquelon, Senegal, Vanuatu, and Wallis and Futuna (collectively known as “Excepted Countries.”)

Global One also seeks authority to provide switched services over private lines (“International Simple Resale” in “ISR”) to all authorized countries, except France.

Global One is a wholly-owned indirect subsidiary of France Telecom S.A. (“FT”). Global One, a Delaware corporation, is 50% owned by ROW Interim Holdco, a Delaware corporation and 50% owned by Atlas Telecommunications S.A., a Belgian company. Atlas is wholly-owned by a French company, Compagnie Generale des Communication

S.A., which is itself wholly-owned by FT. ROW Interim Holdco is wholly-owned by Atlas. (*See Exhibit A.*)

Global One intends to provide telecommunications services to corporate and consumer users as well as to other carriers. Global One currently holds no FCC authorizations to provide international services.

Grant of this Application will serve the public interest, convenience and necessity by promoting competition in the international services market, which will increase service options and foster downward pressure on rates.

This Application qualifies for the Commission's streamlined processing procedures pursuant to Section 63.12, because for each foreign country considered under this application either Global One has no affiliate, or the affiliate qualifies for a presumption of non-dominance under Section 63.10(a)(c). In addition, Global One is only seeking ISR on approved routes.

## II. SECTION 63.18 INFORMATION

- d. Global One has not previously received authorization under Section 214 of the Communications Act.
- e. Global One requests authority pursuant to Section 63.18(e)(1) and 63.18(e)(2) of the Commission's Rules, to acquire and operate facilities and to operate as a global facilities-based and resale carrier except between the United States and Excepted Countries, as defined above. Global One also requests Section 214 authority pursuant to the terms and conditions of Section 63.18(e)(4) of the Commission's Rules to provide ISR between the United States and all authorized countries, except France. Global One will provide these services using authorized cable and satellite facilities. Global One certifies that it will comply with the terms and conditions contained in Section 63.21, 63.22 and 63.23, as appropriate.
- f. Global One will file a separate application for services not subject to streamlined processing, if appropriate.
- g. Authorization of the requested facilities is categorically excluded under Section 1.1306 of the Rules. Therefore, no environmental assessment is required in connection with this application.
- h. *See Exhibit A, "Global One Equity Ownership".*
- i. Global One certifies that it is affiliated with entities that may be considered foreign carriers as described in Exhibit B.
- j. Global One certifies, pursuant to 63.18(j)(3) that it seeks to provide service to all countries except the Excepted Countries. In each of the countries applied for either Global One has no affiliate, or the affiliate qualifies for the presumption of non-dominance under Section 63.10(a)(3). *See Exhibit B.*
- k. Global One is affiliated with carriers in several of the applied-for countries. *See Exhibit B.* Most of these countries are WTO members and all Global One affiliates are non-dominant.
- l. Global One submits that none of its affiliates has market power, under Section 63.10(a)(3) in any of the applied-for countries. *See Exhibit B.*
- m. The affiliates of Global One are non-dominant in the countries which the applicant proposes to serve. *See Exhibit B.*
- n. Global One certifies that it has not agreed to accept special concessions directly or indirectly from any foreign carrier possessing market power

with respect to any U.S. route and will not enter into such agreements in the future.

- o. Global One certifies pursuant to 47 C.F.R. § 1.2001 through § 1.2003, that no party to this Application is subject to a denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988. *See* 21 U.S.C. § 853(a).


- p. Global One qualifies for streamlined processing because in each of the applied-for countries Global One either does not have an affiliate or the affiliate lacks marketpower. *See* Exhibit B.

### III. CONCLUSION

Grant of this application will introduce a new, competitive international telecommunications carrier in the U.S., providing opportunity for additional consumer choice. Global One meets the Commission's eligibility requirements for streamlined processing and requests expeditious grant.


