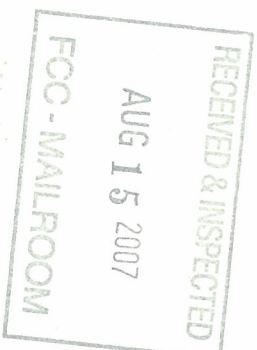

We are the attorneys for New Access Communications, LLC (hereinafter "New Access").
