Application

Primericom L.L.C. ("Primericom"), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Section 63.18, to provide global international facilities-based and resale services between the United States and international points.

Primericom is a new U.S. company organized to provide international telecommunications services. Primericom has no foreign affiliations.
