On June 2, 2005, XO Communications, Inc. (“XO”) filed with the Commission a Notification pursuant to Section 63.21(h) of the Commission’s Rules of Provision of International Service Through Subsidiaries; Notification Pursuant to Section 63.24(f) of the Commission’s Rules of a Pro Forma Transaction; and Notification of Surrender of Authority (the “Notification”) detailing certain changes in the corporate structure of XO and its telecommunications operating subsidiaries. As requested by the Commission’s International Bureau Staff, XO hereby provides the following supplemental information regarding the transactions discussed in the Notification:

1. Effective Date of the Transactions: The transactions discussed in the Notification were effective as of June 1, 2005.
2. Merger of Allegiance Telecom International, Inc.: Allegiance Telecom International, Inc. (File Nos. ITC-95-309, ITC-ASG-20030520-00340) merged into XO Communications Services, Inc., a wholly owned subsidiary of XO. On the date of the merger, the customers served by Allegiance Telecom International, Inc. were transferred to XO Communications Services, Inc.
