

**APPLICATION FOR STREAMLINED  
INTERNATIONAL SECTION 214 AUTHORITY**

Hutchinson Telecommunications Inc. ("Hutchinson" or "Applicant") requests authorization, pursuant to Section 214 of the Communications Act and Section 63.18 of the Commission's Rules, to resell the switched telecommunications services of other common carriers services between the United States and international points. See 47 U.S.C. § 214 (1988); International Section 214 Streamlining Order, 61 Fed. Reg. 15,724, 15,729 (1995) (codified at 47 C.F.R. § 63.18).

Hutchinson requests authorization to operate as a resale carrier pursuant to the terms and conditions of Section 63.18(e)(2) of the Rules. Unless formally opposed, the present application qualifies for streamlined treatment under Section 63.12 of the Rules. See International Section 214 Streamlining Order, *supra* at 15,728 (codified at 47 C.F.R. §§ 63.12).

Hutchinson's proposal will permit it to purchase switched international telecommunications services from other carriers at volume discounts, and to pass through some of its savings to its resale customers. The public interest will be served by Hutchinson's ability to offer additional service options and reduced rates to its customers.

Grant of this application will serve the public interest, convenience and necessity and in support thereof, the following information is submitted pursuant to Section 63.18 of the

Commission's Rules:

d) Hutchinson has not previously received authority under Section 214 of the Communications Act, 47 U.S.C. 214. With the grant of this application, Hutchinson will have international switched resale authority under Section 214 of the Communications Act.

e) Hutchinson is requesting authority under Section 214 of the Communications Act, 47 U.S.C. § 214, to operate as a resale carrier pursuant to the terms and conditions of Section 63.18(e)(2) of the Commission's Rules, 47 C.F.R. § 63.18(e)(2).

Hutchinson: (1) will maintain separate books of account from Hutchinson Telephone Company (HTC), its affiliated local exchange carrier; (2) will not jointly own transmission or switching facilities with HTC; and (3) will take any tariffed services from HTC pursuant to the terms and conditions of HTC's generally applicable tariffs.

Hutchinson will be treated as a nonregulated affiliate of HTC for purposes of local exchange carrier accounting under the Commission's joint cost and affiliate transactions rules as set forth in Parts 32 and 64 of the Commission's Rules.

**Foreign Concessions and Arrangements**

Hutchinson hereby certifies that it has not agreed to accept special concessions, directly or indirectly, from any foreign carrier or foreign administration with respect to traffic and revenue flows between the United States and any foreign country which the Applicant may serve under the authority sought; and that it will not enter into such agreements in the future.

**Anti-Drug Abuse Act Certification**

Hutchinson certifies that, to the best of its knowledge and belief, no party to the application is subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. 862.

CONCLUSION

In light of the foregoing, Hutchinson respectfully submits that the public interest, convenience and necessity would be served by a grant of the Section 214 authorization sought, and that such authorization should be issued to it for purposes of reselling the switched services of other common carriers to provide international switched telecommunications services between the United States and international points.
