This letter is submitted for association with the Commission's files concerning the above-referenced certification granted to Telepak Networks, Inc. ("TNI") under Section 214 of the Communications Act of 1934, as amended, to provide global resale services. When the application was filed on January 31, 2001, TNI identified itself as a wholly-owned subsidiary of Telapex, Inc. This letter is to supplement the Commission's records with information concerning two additional wholly-owned subsidiaries of Telapex, Inc. which also provide or will provide global resale services: Telepak, Inc. and Cellular South Licenses, Inc.

Please note that Telepak, Inc. is the new name for the merged entities Cellular Holding, Inc. and Mississippi Cellular Telephone Company which were granted international Section 214 certifications on April 2, 1997 (See FCC File Nos. ITC-214-1997-00083 and ITC-214-1997-00084, respectively). Cellular South Licenses, Inc. is a recently formed entity that is wholly owned by Telepak, Inc. and which plans to offer global resale services as a licensee in the Commercial Mobile Radio Services.
