Notification of Discontinuance of International Telecommunications Services

Dear Secretary Dortch:

Lavaca Telephone Company, Inc. (the "Company"), pursuant to Section 214(a) of the Communications Act of 1934, as amended, and 47 C.F.R. Section 63.19, notifies the Commission that it plans to discontinue the offering of international telecommunications services. Currently, Lavaca does not itself provide international telecommunications service and has no international telecommunications service customers. Lavaca's subsidiary, Vantage Telecom LLC d/b/a Pinnacle Telecom ("Vantage"), however, has approximately 135 numbers in Arkansas, Missouri, and Oklahoma served using commercial wholesale platform services (i.e. UNE-P) who subscribe to Vantage's international telecommunications service provided by Vantage under Lavaca's Section 214 international authorization.

Vantage plans to discontinue international telecommunications services to all customers, including these customers in the States of Arkansas, Missouri, and Oklahoma on January 5, 2021, or as soon thereafter as Commission approval can be obtained. The Company provides the following information:

2. Date of Planned Service Discontinuance, Reduction or Impairment:

January 5, 2021, or as soon thereafter as Commission approval can be obtained.

3. Points of Geographic Areas of Service Affected:

The Company plans to discontinue international telecommunications services to customers in the States of Arkansas, Missouri, and Oklahoma.

4. Brief Description of Types of Service Affected:

The Company, through its subsidiary Vantage, provides international calling services to customers served through commercial wholesale platform services purchased from third party carriers in the States of Arkansas, Missouri, and Oklahoma. The Company is now discontinuing international telecommunications services to all customers in the affected geographic areas of service on a 30-day notice.

5. Brief Description of Dates and Methods of Notice to All Affected Customers:

The Company provided written customer notice of the planned discontinuance in accordance with the requirements of Section 63.19 of the Commission's Rules. The notice was sent to all affected customers via U.S. mail on December 4, 2020. A copy of the notice is provided as Exhibit A.

6. Non-Dominance of the Carrier With Respect to the Service to be Discontinued:

The Company is non-dominant with respect to the services to be discontinued.

The Company has provided the requisite notice to all of its affected customers, which have access to several other substitute services including VoIP service and service from the incumbent carrier that supplies the wholesale platform service to Vantage.

As a result of the evolution of communications technology and the communications marketplace, Vantage Telecom LLC dba (Pinnacle Telecom) will no longer offer international long distance telecommunications services to its customers in Arkansas, Missouri, and Oklahoma that are not served using Pinnacle Telecom's own network. Unfortunately, your account contains services that are not currently wired to Pinnacle Telecom's network and therefore Pinnacle Telecom will no longer be able to provide you international long distance telecommunications services on these lines. All traditional landline international long distance telecommunications services will be discontinued effective January 5, 2021, or as soon thereafter as the necessary regulatory approvals can be obtained. Long distance calling within the United States is not affected by this change. Following is a list of the affected service:
