REQUEST FOR SECTION 214 AUTHORIZATION

Section 63.18, to provide global international facilities-based and resale services between the United States and international points.

Hola has been certified by the Telecommunications Regulatory Board of Puerto Rico ("Board") as a Competitive Local Exchange Carrier ("CLEC") in 2000 to provide telecommunications services within Puerto Rico., Docket No. JRT- 2000-CER-0011.

By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. and P.R. consumers by increasing service optional and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to Hola.




