COMIndico US Inc. ("COMIndico"), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and Section 63.18 of the Commission's Rules, to provide global international facilities-based and resale services between the United States and international points.

COMIndico is a new U.S. company organized to provide, among other things, international telecommunications services. COMIndico is a wholly owned subsidiary of COMIndico International Pty Ltd., a corporation organized under the laws of Australia. COMIndico intends to serve business customers throughout the United States by providing competitively priced international telecommunications services.

By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to COMIndico.

- (i) COMMindico certifies that it is controlled by **or** under common control with and therefore affiliated with COMMindico Australia Pty Ltd, a foreign carrier, as defined in Section 63.09(d) of the Commission's Rules, in Australia.
- (j) COMMindico certifies that it is indirectly controlled by COMMindico Holdings Pty Ltd, which also controls COMMindico Australia Pty Ltd, a foreign carrier in Australia and COMMindico seeks to provide international telecommunications services to Australia.
- (k) Australia is a member of the World Trade Organization. See KDD America, Inc., DA 00-2587, 2000 FCC LEXIS 6083, & 10, (November 15, 2000); see also, MFS International, Inc., 14 FCC Rcd 13912, 13914 (1999).
- (l) COMMindico's affiliate, COMMindico Australia Pty Ltd lacks sufficient market power in Australia to affect competition adversely in the U.S. market. COMMindico certifies that COMMindico Australia Pty Ltd lacks fifty percent (50%) market share in the international transport and the

local access markets in Australia. COMMindico satisfies Section 63.10(a)(3) of the Commission's Rules.

- (m) As set forth above in (l), COMMindico Australia Pty Ltd lacks sufficient market power in Australia to affect competition adversely in the U.S. market and COMMindico should be classified as a non-dominant carrier pursuant to Section 63.10(a)(3) of the Commission's Rules.
- (n) COMMindico certifies that it has not agreed and will not agree in the future to accept any direct or indirect special concessions from a foreign carrier or administration with regard to traffic or revenue flows between the United States and any foreign countries the company is authorized to serve.
- (o) COMMindico certifies that no party to this application has been denied federal benefits pursuant to Section 530 of the Anti-Drug Abuse Act of 1988.
- (p) COMMindico desires streamlined application processing pursuant to Section 63.12 of the Commission's Rules. As set forth in (k) above, the relevant destination market (Australia) is a WTO member country. As set forth in (l) above, COMMindico qualifies for a presumption of non-dominance under Section 63.10(a)(3) of the Commission's Rules. COMMindico therefore qualifies for streamlined processing under to Section 63.12(c)(1)(ii) and (iv) of the Commission's Rules.

Conclusion

In conclusion, COMMindico certifies that all of the information in this application is accurate and correct.

For these reasons, COMindico respectfully requests that the Commission grant this application.
