TelecomEZ Corporation (“TelecomEZ”), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Section 214 (1982), and Section 63.18 of the Commission’s rules, 47 C.F.R. Sec. 63.18, to provide global international resale service between the United States and international points.

TelecomEZ is a new U.S. Company incorporated to provide international telecommunications services. The purpose of the company is to act as a service bureau for telecommunications carriers as a call processing center, providing operator service, customer service, and telemarketing service bureau activities. TelecomEZ has no foreign affiliations.

By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 to TelecomEZ.




