Re: Xspedius Communications, LLC d/b/a tw telecom inc. Surrender of  
International Section 214 Authorization Not Required for Operations

Dear Ms. Dortch:

tw telecom inc. hereby updates the Commission's records and surrenders the International Section 214 authorization, File No. ITC-214-20010326-00153, which is currently held by Xspedius Communications, LLC ("Xspedius"). On September 15, 2006, Time Warner Telecom, Inc. obtained control of the International Section 214 authorization at issue.<sup>1</sup> On July 1, 2008, Time Warner Telecom, Inc. changed its name to tw telecom inc.<sup>2</sup> The indirect, wholly-owned subsidiaries of tw telecom inc. listed on the attached page will provide international telecommunications services pursuant to the International Section 214 authorization, File No. ITC-214-20000927-00570, held by tw telecom holdings inc., a direct, wholly-owned subsidiary of tw telecom inc.,<sup>3</sup> instead of the aforementioned International Section 214 authorization held by Xspedius, and will do business as tw telecom. The entities listed on the attached page are indirect, wholly-owned subsidiaries of tw telecom holdings inc. This surrender of International Section 214 authority does not involve the discontinuance of service to any customer.
