KTNT Communications, Inc., a Texas corporation, hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 (1982), and 47 C.F.R. § 63.18, to provide global international telecommunications resale service between the United States and international points.

KTNT Communications, Inc., is a U.S. company organized to provide telecommunications services. The Corporation has no foreign affiliations. The Corporation intends to serve customers throughout the United States.

(d) The Corporation is a domestic resale common carrier subject to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 (1982). The Corporation has not previously received authority under Section 214 of the Act.

(e) The Corporation requests global resale Section 214 authority pursuant to the terms and conditions of 47 C.F.R. § 63.18(e)(2).

(f) At this time, the Corporation seeks no other authorization available under 47 C.F.R. § 63.18(e).

(g) The Corporation certifies that it will comply with the terms and conditions of 47 C.F.R. §§ 63.21 and 63.23.

(h) The Corporation certifies that it is not affiliated with any foreign or U.S. facilities-based carrier and has no interlocking directorates with a foreign carrier. - (j) The Corporation certifies that it has not agreed and will not agree in the future to accept any direct or indirect special concessions from a foreign carrier with respect to any U.S. international route where the foreign carrier possesses sufficient market power on the foreign end of the route to affect competition adversely in the U.S. market.
- (j) The Corporation certifies that no party to this application has been denied federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. 862.
- (k) The Corporation certifies that it is not a foreign carrier, does not control a foreign carrier, and no entity owns 25 per cent or more of the Corporation.
- (l) The Corporation requests streamlined processing of its application pursuant to Section 63.12, as it is a non-dominant carrier with no facilities and no affiliations with foreign or domestic carriers whose traffic it intends to resell, does not seek authority to provide switched basic services over private lines, and has not been informed that it is ineligible for streamlined processing.

In conclusion, KTNT Communications, Inc. respectfully requests that the Commission grant this Section 214 application for global authority to operate as an international resale carrier.
