Application

Neu-Firmnet Inc. (“Neu-Firmnet”), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Section 214 (1982), and Section 63.18 of the Commission’s Rules, 47 C.F.R. Section 63.18, to provide global international facilities-based and resale services between the United States and international points.

Neu-Firmnet is a newly established California corporation with no foreign affiliation. Its main business is to service U.S. telecommunication carriers and connect them with foreign carriers. The major foreign market Neu-Firmnet engages in is the People’s

Republic of China, with future expansion possibility into European countries. Neu-Firmnet charges U.S. carriers per minute fee to connect them to PRC, and Neu-Firmnet will enter into business contracts with PRC domestic carriers to lease their infrastructure lines.

By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Thus, the public interest will be served by the grant of Section 214 authority to Neu-Firmnet.

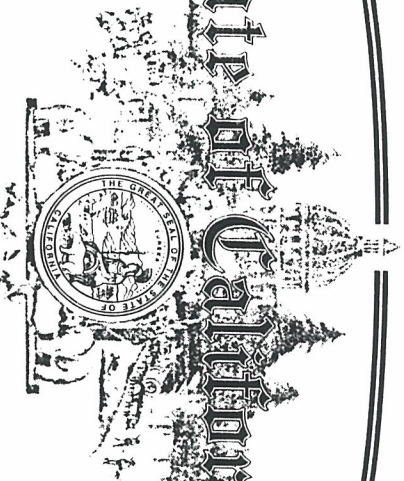
