CRAMSTAFF INTERNATIONAL, INC. ("CRAMSTAFF"), hereby requests authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Section 214 (1982), and Section 63.18 of the Commission's Rules, 47 C.F.R. Section 63.18, to provide global international facilities-based and resale services between the United States and international points.

CRAMSTAFF is a new U.S. company organized to provide international telecommunications services. CRAMSTAFF has no foreign affiliations. CRAMSTAFF serves business customers throughout the United States. (Alternatively: CRAMSTAFF was granted Section 214 authority to provide international switched service between the United States and various international locations. The Commission's approval is stated in File No. I-T-C-9X-xxx (199X).)
