APPLICATION

Advance Global Communications, Ltd. ("Applicant") hereby requests global facilities-based and resale Section 214 authority pursuant to the terms and conditions of Section 63.18 of the Commission's Rules, 47 C.F.R. Section 63.18. Applicant is a Cayman Islands corporation organized to provide international telecommunications services. By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. 
