BTS holds an international Section 214 authorization to provide global or limited global facilities-based service (ITC-214-2001092-100482). BTS is a direct, wholly-owned subsidiary of its parent, BTS Group, Inc. ("BTS Group"). They are U.S. residents for tax purposes and hold investor visas. (ii) *A certification that the transfer of control or assignment was pro forma and that, together with all previous pro forma transactions, does not result in a change in the actual controlling party.*


