Re: Surrender of International Section 214 Authorizations

Dear Ms. Dortch:

Verizon Communications Inc. ("Verizon"), on behalf of the wholly-owned subsidiaries identified below hereby surrenders the following international Section 214 authorizations effective immediately. The Section 214 authorizations listed below are no longer necessary because they are associated with submarine cable systems that have since been retired and are no longer in use or they are duplicative of other global international Section 214 authority held by the listed Verizon subsidiaries. Accordingly, the Section 214 authorizations are unnecessary, and their surrender does not affect the authority for the enumerated Verizon subsidiaries to provide services or facilities to customers.
