Howard and David -

I spoke this afternoon with Susan O'Connell about the pending pro forma transfer of control Title II notification, Title III transfer of control application and Petition for Declaratory Ruling for SkyWave Mobile Communications, Inc. ("SMCI") and SkyWave Mobile Communications, Corp. ("SMCC"). Currently, both

SMCI and SMCC hold International Section 214 authority to provide the Immarsat D+ service.

In order to continue processing the pending transfer applications and declaratory ruling, Susan and I agreed that it made sense at this point for SMCC to surrender its Section 214 authorization (which is not currently part of the pending applications) and provide notification that it will operate (to the extent necessary) under the Section 214 authority currently held by its parent corporation, SMCI. SMCI is the entity that sells and offers the Immarsat D+ service in the United States, while SMCC holds the relevant Title III authorization.

Susan wanted me to let each of you know what we plan to do. Please let me know if there are any issues with this approach; otherwise, we plan to submit a letter tomorrow (Friday) to this effect so that the pending SkyWave transfer applications can continue to be processed accordingly.
