# Response to Item 9 - Streamlined Processing

Applicant seeks streamlined processing pursuant to Section 63.12 of the Commission's rules, on all international routes except the U.S. - Netherlands Antilles ("Antilles") route. UTS-USA is a new U.S. company organized to provide international telecommunications services. UTS-USA is a whole owned subsidiary of United Telecommunication Services, S.A. UTS-USA therefore has a foreign an affiliation with United Telecommunication Services, S.A. which has dominant carrier status on the U.S. - Netherlands Antilles ("US-Antilles") route (United Telecommunication Services, ITC-214-20021007-00484). The Netherlands Antilles is a WTO member country, and UTS-USA's provision of international services via resale of unaffiliated U.S. facilities-based carrier services will be regulated as non-dominant pursuant to Section 63.10(a)(4) of the rules. UTS-USA qualifies for a presumption of non-dominance under Section 63.10(a)(1) of the Commission's rules, as it holds no foreign carrier affiliations on such routes, apart from the agreed dominance of the US-Antilles route. This application is thus subject to streamlined processing pursuant to Sections 63.12(a)(1)(iv)-(v).

## Response to Items 11-13 - Foreign Carrier Affiliations Section 63.18(i) Information.

**Applicant hereby certifies that it holds the following foreign carrier affiliation**: UTS-USA has an affiliation with United Telecommunication Services (ITC-214-20021007-00484) a foreign carrier in the Netherlands Antilles. United Telecommunication Services provides local and international long distance services for the Island of Curacao and the Antilles Route.

### Section 63.18 (j) Information.

UTS-USA certifies that it seeks to provide international telecommunications services to the Netherlands Antilles wherein the sole stockholder of UTS-USA, United Telecommunication Services, is a foreign carrier in that country.

### Section 63.18(1)-(m) Information.

UTS-USA has no foreign carrier affiliation on routes other than the US-Antilles Route and is thus deemed non-dominant pursuant to Section 63.10(a)(1) of the rules. Applicant agrees to affiliation with a carrier that has dominant regulatory status on the US-Antilles Route. For purposes of applicant's service provided solely via the resale of unaffiliated U.S. facilities-based carriers' international switched services, Applicant agrees it will file quarterly traffic reports pursuant to Sections 63.10(c)(3) and 43.61(c) of the rules for the US-Antilles Route; Applicant's provision of such service will therefore be treated as non-dominant pursuant to 47 C.F.R. § 63.10(a)(4).
