**Re: Des Vieux Telecoms, Inc. Notice of Discontinuance of Service and Surrender of International Section 214 Authorization**

Des Vieux Telecoms, Inc. (“DVT”) hereby requests to surrender its Section 214 Authorization (ITC-214-20041222-00490), pursuant to Section 214 of the Communications Act of 1934, as amended, and Section 63.19 of the Commission’s rules (47 U.S.C. § 214 and 47 C.F.R. § 63.19). DVT operated as a reseller of international telecommunications services using its 214 Authorization obtained in 2005, and now seeks to surrender this authorization. DVT has not provided telecommunications services to retail customers, but has provided service on a wholesale basis only to five other carriers located in Florida (Miami) and New Jersey (East Brunswick and Newark).

In each case, the commercial arrangement between DVT and the carriers was terminated by mutual consent and/or according to contract terms between DVT and the respective carrier. The following table provides the information of each carrier and the circumstances relating to the termination of each commercial arrangement.
