

Pursuant to RCW 23B.10.060, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation.

- 1. The name of the corporation is TelePacific Communications Co.
- 2. The text of the amendment adopted reads as follows:

Article 1 of the Articles of Incorporation of the corporation shall be amended to read in its entirety as follows:

- "1. The name of the corporation is TPx Communications Co."
- 3. The amendment was adopted on February 27, 2017.
- 4. The board of directors adopted the amendment without shareholder action pursuant to RCW 23B,10.020(5), which provides that shareholder action is not required to change a corporate name unless the articles of incorporation provide otherwise.
