Pursuant to Section 1.65 of the Commission's Rules, 47 C.F.R. § 1.65, Stratos Communications, Inc. ("Stratos Communications") hereby seeks to amend and update its pending applications to reflect the transfer of control and Petition for Declaratory Ruling that was granted as part of the Commission's Order in *In the Matter of Stratos Global Corporation, Transferor and Robert M. Franklin, Transferee*, Memorandum Opinion and Order and Declaratory Ruling, FCC 07-213 (Dec. 7, 2007) ("Order"). 
