- 3. Wabash Independent Network, Inc., 210 Church Street, PO Box 299, Louisville, IL 62858, is organized in the United States. The company is 100% owned by Wabash Telephone Cooperative, Inc. ("WTCI") of the same address which is also

- organized in the United States. WTCI is organized as a cooperative in which no owner holds as much as a 10% interest.
- 4. Egyptian Communication Services, Inc., 1010 W. Broadway, Steeleville, IL 62288, is organized in the United States. The company is 100% owned by Egyptian Telephone Cooperative Association ("ETCA") of the same address which is also organized in the United States. ETCA is organized as a cooperative in which no owner holds as much as a 10% interest.
- 5. Hamilton County Communications, Inc., Highway 142, PO Drawer B, Dahlgren, IL 62828, is organized in the United States. The company is 100% owned by Hamilton County Telephone Cooperative, Inc. ("HCTC") of the same address which is also organized in the United States. HCTC is organized as a cooperative in which no owner holds as much as a 10% interest.

("Fairpoint") of the same address which is also organized in the United States. Fairpoint controls numerous FCC regulated entities and has reported in filings with the FCC that the following entities own more than a 10% interest in Fairpoint: (1) Kelso Investments Associates V, L.P., 320 Park Avenue, 24th Floor, New York, NY 10022 holds approximately a 10.60% equity interest in Fairpoint and is organized in the United States; and (2) Thomas H. Lee Equity Fund IV, LP, 75 State Street, Boston, MA 02109, holds approximately a 12.5% voting interest in Fairpoint and is organized in the United States.
