Please review the following applications and advise us whether you have any national security, law enforcement, foreign policy or trade concerns by **C.O.B. April 26, 2006**, because we are prepared to take action on these applications. **Electronic filed (e-file) applications are able to be viewed by accessing www.fcc.gov/ibfs and searching by the file number.**

ITC-214-20060405-00188 (e-file)

AllAccess, Inc.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Applicant is indirectly 100% owned by a **Mexican** corporation, which is 70% and 15% owned by two citizens of **Mexico** respectively.

ITC-214-20060404-00189 (e-file)

International Communication's Service's, Inc.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Applicant is 85% owned by a **Mexican** corporation, which is 70% and 15% owned by two citizens of **Mexico**, respectively. Applicant is also 15% indirectly owned by a citizen of **Mexico**.

ITC-214-20060404-00180 (e-file)

BT Fifty-Three Ltd.'s application for authority to provide Inmarsat Broadband Area Network (**BGAN**) Mobile Satellite Services as a facilities-based and resale provider of domestic and international mobile satellite service via the Inmarsat 4F2 Satellite at 52.75 degree W.L.

Applicant and its U.S. operating affiliates agree to be classified as **dominant carriers** on the U.S. - **U.K. route**, without prejudice to their right to petition for reclassification at a later date.

BT Americas separately has filed an application with the Commission for a **blanket license** to operate 20, 000 mobile earth terminals ("METs") with Inmarsat's **BGAN** service. See File Nos. SES-LFS-20060303-00343, SES-AMD-20060316-00448. BT Americas also has sought **special temporary authority** from the Commission, pursuant to section 25.120 of the Commission's rules, to operate up to 5,000 METs.

Applicant is owned jointly by two **U.K. corporations**, with each holding 33% and 67% ownership interests, respectively. Applicant's ultimate corporate parent is BT Group plc., a **U.K. corporation**.

ISP-PDR-20060221-00003 (e-file)

Telemetrix Inc. ("Telemetrix" or the "Petitioner") requests a declaratory ruling that it is in the public interest to permit indirect foreign ownership of its wholly-owned subsidiary, Tracy Corporation II ("Tracy II"), in excess of the 25 percent benchmark set forth in section 310(b)(4) of the Communications Act of 1934, as amended (the "Act"). Tracy II holds a PCS license for Basic Trading Area 411, which serves the geographic area of Scottsbluff, Nebraska and western Wyoming; and twenty-seven (27) paging and mobile telephone licenses serving various locations in Western Nebraska, Eastern Wyoming, and Northeastern Colorado.

Telemetrix filed its petition in connection with a pending application for consent to transfer control of Telemetrix and its subsidiary, Tracey II, to a group of shareholders that will consist of certain existing foreign shareholders of Telemetrix and new foreign investors. See ULS File Number 0002156736. Aggregate foreign ownership would total 70.76 percent from individuals and entities that are citizens of, or organized in, Canada, the United Kingdom, and the Cayman Islands.

If we do not hear from you by **C.O.B. April 26, 2006**, we will assume that you do not have any concerns with these applications.
